



Brief on Sainik Schools

Sainik Schools, conceived in 1961 by V. K. Menon, the then Defence Minister of India, are established and managed by The Sainik School Society under Ministry of Defence. The primary objective of Sainik Schools was to rectify the regional and class imbalance amongst officer cadre of the Indian Military and prepared students to enter National Defence Academy, Indian Naval Academy. Sainik Schools come under the purview of respective state Governments and Ministry of Defence. Currently there are 33 such schools covering all the states of the Country.

The idea of Sainik Schools came from the Rashtriya Indian Military College (RIMC) which have given India many service Chiefs and the Public school system of England. Sainik Schools is like ordinary citizen's public school where deserving students can get high-quality education irrespective of their income or class background. Reserved Seats for SC/ST and Serving/Retired Defence personnel children.

The objective of the Sainik Schools is to prepare the students to lead as officers in the Defence Services of the Country. The Schools select bright and promising students through an All India Sainik School Entrance Examination and focus on molding their overall personality with an emphasis on extracurricular activities.

Sainik Schools resources allow cadets to develop their skills in Sports, Academics and other Extracurricular Activities. Infrastructure in Sainik Schools includes running tracks, cross-country tracks, indoor games, parade grounds, boxing rings, firing ranges, canoeing clubs, horse riding clubs, mountaineering clubs, trekking and hiking club, football, hockey and cricket fields, as well as volleyball and basketball courts. Compete in sports, physical training, academics, cross country, drill and various other competitions throughout the world.

Objectives of The Proposed Project

- To instill Military values among boys and girls and inspire them to join the armed forces.
- To prepare 630 students to lead as officers in the Defence services of the country.
- To develop skills of bright students in sports, academics, and other extracurricular activities.

Location of The Proposed Project

The proposed Sainik School will be established at Mota Randha, Silvassa, Union Territory of Dadra & Nagar Haveli & Daman & Diu.





Beneficiaries Selection

Admissions will be confined to boys/girls in sixth to ninth standard, completely on the merit basis as per the written examination, interview and medical examination. Qualified students will be enrolled to the school. 35 percent of the total students enrolled at the academy will be girls.

Rationale of The Project

We intend to groom boys and girls enrolled in our academy to become responsible citizens by way of infusing in them the qualities of dedicated and disciplined military personnel. Associating the youth of the far-flung areas into mainstream and making them realize that Bharat is the only true religion. High quality education with all round development of the youth of the country is the need of the hour. Quality education will certainly prepare students for employment and better economic opportunities and thereby holistic development of the society. Following the footprint of Netaji, academy will inculcate proactive attitude in our children.

The focus of the academy will also be on the military training to develop high sense of discipline, physical and mental well being, developing competitive spirit, camaraderie and achieving the cutting edge in one's latent personality so as to excel in all fields. Military training will be compulsory for all cadets and comprise of below mentioned activities.





Proposed Infrastructure

The proposed school will span across 21 acres of land in Mota Randha, Silvassa, Union Territory of Dadra & Nagar Haveli & Daman & Diu. Layout of the same has been attached below Facilities which will be established are enlisted below.

Proposed Infrastructure

The construction of hostels will facilitate 630 students who will come to the academy for studies. The hostel accommodation will help them study well and enable them to use academy's resources as far as possible. Hostels will be equipped with dormitory beds, cupboards and other essentials for students. The hostel will have sanitation blocks and supply of clean drinking water to ensure health and hygiene of our students. Separate hostel blocks will be constructed for boys and girls.

The dining hall will be constructed with the capacity to accommodate 630 students. At Netaji Subhash Chandra Bose Academy, we intend to instill a sense of community by serving all meals to our students so that they can eat together and bond over this shared experience. Clean and hygienic kitchen will be set up with all necessary equipment. Nutritious and wholesome meals will be provided to ensure adequate nutrition.





Proposed Infrastructure

Indoor and Outdoor Sports Facility



An indoor stadium of National standard will be established, which will host all indoor games such as basketball, volleyball, table tennis, chess etc. The stadium will have capacity of 1000 spectators. State of the art outdoor sports facility will also be established within the premise of the Sainik School.





Indoor and Outdoor Shooting Range

Indoor shooting ranges will be constructed considering basic requirements for operating he range safety, proper ventilation, acoustic isolation and appropriate lighting. Outdoor shooting ranges will be used for longer distance shooting. This will aim to train students to deal with exposure to elements such as wind, dust and rain.

Swimming Pool

Swimming pool with all modern facilities will be made available and taught as an extracurricular activity to cadets.

Computer Lab

With ever increasing penetration of technology in almost every sector, enhancing skill on computer is of paramount importance. Computer literacy is becoming an essential part of the mainstream education. Two computer labs equipped with internet, multimedia facilities and latest configurations on computers will be established.

Computer skills are becoming as important as math, language and science education and governments around the world are looking for the most efficient ways to provide computing access for their students.

Computer labs will be established with the aim to improve communication and learn to use this vast resource to students' advantage. Computer literacy will help students tackle the knowledge gap and keep them up-to-date with latest developments around the world.

Science Lab

We intend to establish ultra-modern science laboratory with state of the art facilities that can accommodate batch of 60 students at the same time. We believe in promoting and environment of learning where children tend to learn faster when they are able to visualize their lessons and are enthused by the practical application of subjects. Science labs will promote learning through experience and will provide an open environment for children to innovate and create projects, working models or carry out experiments with research purpose.

Library

To inculcate reading skills among cadets, state of the art library will be established. The library will have genre of books, newspapers, magazines and other important academic materials. A digital library, an online database of digital objects will also be made available to cadets.

Apart from the above mentioned infrastructures, artificial mountaineering wall, gymnasium, yoga center, hospital will also be established within the premise.





While major emphasis will be laid on the academic progress of the students, the school will also provide wide scope for the development of their creative faculties. Students will be motivated to learn by participating in various activities according to their aptitude. The school will have various clubs.

Education tours form an essential part of the school curriculum. Students will be taken to various important places of educational interest including defence training centers.

Enrollment in National Cadet Corps will be compulsory for all students. The cadets will be assisted by well qualified NCC officers and instructors.

The permission is granted subject to the provisions of Dadra & Nagar Haveli Development Control Rules-2014. 2

permission shall be valid for a period of Three Years from the date of issue of building The permission.

3 Coverage, setbacks and built up areas shall be strictly maintained as per the approved plan.

- 4 The Fire Safety measures as per the National Building Code & Factories Act shall be made by the applicant. The applicant shall also comply all the provisions/ measures stipulated the Fire Department in its Provisional NOC issued vide letter No. DFES/SFO/DNH/NOC/CPEdu.bldg./2021/329 dated 26.05.2021 and obtain the Final NOC at the time of Occupancy Certificate. No Occupancy Certificate shall be issued without Final NOC of Fire Department.
- The site properly be developed with filling and leveling etc. prior to carrying out any construction 5 work. Internal road shall be developed with asphalted surfaced to the required and to the satisfaction of the Competent Authority. Proper cross drainage to the plot should be provided for storm water drain to avoid
- water logging. Adequate capacity of soak pit & septic tank shall be provided so that there should not be any discharge of effluent from the building. 7
- The responsibility of any error in dimensions or area of the plot or area statement shown in the building plan or ROW abutting to the land shall be of the applicant and his Architect concerned. In case, this approval is obtained by submitting the false statement/details in the building plan as well as in documents, then this approval shall be withdrawn at any time without any prior notice to the applicant/Architect concerned, and any liabilities/loss consequent upon the withdrawal of this approval, shall be with the owner of the land.
- 8 Construction shall be strictly carried out as per the approved plan. Any unauthorized construction shall be demolished at risk and cost of the party concerned. On finding any deviated construction at any stage of work from the approved plan
- In case of any emission/effluent etc., the same shall be disposed off after adequate treatment to 9 the satisfaction of the Competent Authority so that no pollution/health/environment degradation takes place. The building/unit will be closed down at the risk & cost of the party concerned if any violation on the above is observed
- No development work is allowed within 6mtrs.from the bank of kotar and the land owner will make 10 land available from road widening free of the cost keeping in view the requirement of accessibility as and when the same is required.
- Optimum number of trees should be planted in the open/margin space of the plots. 11
- The compound wall has to be constructed after 12.5 mt from the centre of 25.00mt road and road 12 side gutter has to be maintained so that there is no obstruction of water flow.
- 13 The accessibility to the land Srv.No.209 shall be provided from the subject land as demarcated in the approved plan for their access purpose.
- 14 Structural design of the building should be as per the National Building Code of India (latest version), taking in to consideration the Indian Standards and Safety guidelines given for Earthquake protection and cyclone/wind storm protection. Structural design submitted with the proposal is only for office records and submission of the same may not be assumed as approval of
